Main Purpose of the Role

The North Project team undertakes the following streams of work:

- Landscape and catchment-scale habitat restoration and creation, particularly:
  - o river restoration to improve habitat for fish, invertebrates, reduce agricultural run-off and areas of unnatural erosion and sediment.
  - wetlands for waders and plant communities
  - o ponds for Great Crested Newts and ark sites for White-Clawed Crayfish
  - o invasive species control
  - o reintroduction of rare wetland plant species into the landscape.
- Surveying and monitoring of habitats and species to identify issues, plan remedial work and measure the impact of any interventions.
- Stakeholder engagement to encourage landowners and land managers to take action for nature's
  recovery by advising them on how to benefit from the projects we are delivering or via other
  funding opportunities (e.g. agri-environment schemes).

#### As Project Officer, you will:

- Help deliver our landscape and species recovery projects across the North Yorkshire area safely, on time, within budget and to a high standard.
- Work with the staff team to deliver practical tasks and survey field work, in addition to liaising with volunteers, stakeholders and contractors.
- Be flexible in your approach and able to assist on different projects according to where funding has been secured.
- Be closely supported and mentored by the Projects Manager and our partners.





## Tasks and responsibilities

- Engage with landowners, land managers and contractors to deliver practical interventions.
- Conduct on the ground surveys and monitoring.
- Produce reports with recommendations for improvements and investment.
- Engage with staff, landowners, partners, and volunteers in a positive proactive manner.
- Support the coordination of volunteers by providing training and assigning relevant tasks.
- Deliver any scheduled events and activities which raise awareness and understanding of the value of the project to relevant stakeholders.
- Undertake record keeping of interventions and surveys, some input into the projects GIS mapping.
- Cultivate relationship with project funders and partners, ensuring excellent communication is
  provided via regular updates, in addition to the production and submission of project claims and
  reports.
- Engage with key stakeholders and attend (or lead, where appropriate) regular meetings.
- Manage delegated projects and project budgets, ensuring effective use of resources.
- Create the foundation for further projects and action to tackle the issues identified and actively
  work to secure additional funding to deliver these actions and interventions. This will include
  investigating funding outside of environmental stewardship options which could be secured to
  implement identified on-farm measures.

Salary:	£27,697-30,811 per annum (pro rata if part-time).
Hours:	35 hours per week, Monday to Friday.
	The nature of the post's duties may occasionally require evening and/or weekend work.
	Paid overtime is not available, but time off in lieu will be given for essential additional hours worked.
Contract:	3-year contract from 1 <sup>st</sup> January 2026 – 31st March 2029. A probationary period of 6 months applies to new staff, during which you must complete all essential, mandatory training.
Flexibility:	Whilst ensuring the needs of the business and the role are met, the Trust endeavours to meet the flexible working needs of its employees. Depending on the nature of the role, the Trust offers hybrid working (a mix of office and at home).
Holidays:	30 days per annum inclusive of 3 office/site closure days over the Christmas period, in addition to national public holidays, rising to 33 days after 5 years' service. All leave is pro rata for part time employees.
